Oral Systemic Connection

- Studies show more than 90 percent of all systemic diseases have oral manifestations.
- Children who have poor oral health often miss more school and receive lower grades than children who don't.
- Poor oral health is linked to serious medical conditions such as heart disease, stroke, and diabetes.
- Each year more than \$6 billion is lost in productivity due to people missing work for dental issues.

Health First Colorado Benefits





Child members (20 and under) have no out of pocket cost for covered services, no annual maximum, no deductible or co-pays.

Plan covers a wide range of preventive and restorative care and emergency services.

Orthodontics are covered <u>IF</u> determined to be medically necessary





•The Health First Colorado adult dental benefit is increased from \$1,000 to \$1,500 per fiscal year effective July 1, 2019.

•Benefit covers a variety of preventive and restorative services.

Dentures and Emergency care are covered outside of the \$1,500 annual benefit & don't count against that benefit.

How much care can the \$1,500 benefit provide?

• Preventive Services: Exams, X-Rays, Cleanings

• Examples of higher cost procedures: Root Canals, Surgeries, Crowns, Anesthesia

DIDD Waiver

Division of Intellectual/Developmental Disabilities

Waiver participants have the \$1,500 adult benefit.

In addition, adult waiver participants may receive up to \$2,000 in basic/preventative benefits per year <u>and</u> have access to additional services through the waiver.

They may also receive up to \$10,000 in major dental benefits over the 5-year span of the waivers.

Coverage includes, but is not limited to:



- Exams
- X-rays
- Cleanings
- Fillings
- Crowns
- Root Canals
- Extractions

- Periodontal
 Cleanings (deep
 cleanings used to
 treat gum disease)
- Dentures/Partials
- Dental Emergencies

CHP+ dental Benefits

CHP+ Coverage

Child members are 0-18 years

Coverage for Pregnant women begins Oct. 2019.

(Coverage will end 60 days after the last day of the month when the pregnancy ended.)

\$1,000 in covered services each calendar year (Jan. 1-Dec. 31st)



CHP+ Coverage

May have to pay an annual enrollment fee. (\$0 for pregnant women)

•No co-pays for covered diagnostic and preventive procedures.

•May have to pay small co-pays for other services.

•Limited orthodontic benefit for children.

How Medical Practices can Support Patient Access and Utilization

• Screen for recent dental visit during annual wellness check-ups

- Create own list of 10 General and 10 Pediatric Dental offices closest to the practice and build relationships with those offices
- - "Find a Dentist" feature online
- Suggest members create a login to access their benefit information and to access live chat feature: memberaccess.dentaquest.com

How Medical Providers can Support Patient Access and Utilization

•Health First Colorado only:

- Share with members that if they are eligible for Non-Emergent Medical Transportation that includes dental visits
- PCP Integration Pads (Exam rooms, lobby, front desk checkout/check-in)
- Hang Benefit Posters in Lobby and/or in Exam rooms
