Agenda Items	
Welcome, Intros	 Becky welcomed members and explained she was facilitating virtually due to illness. Spanish interpretation was available, though technical challenges occurred; staff and interpreters worked together to troubleshoot. Reviewed agenda: introductions, hopes and group norms, executive committee selection, presentations on population health assessment and policy updates, future priorities, and Q&A. Participants introduced themselves by sharing their role or lived experience, what they bring to the group, and what they hope to gain. Expertise in pediatrics, behavioral health, disability navigation, maternal health, and member advocacy.

	Members expressed interest in improving coordination, navigating Medicaid changes, and amplifying lived experience alongside professional expertise.

- How are social determinants of health incorporated into member assessments, especially for pediatrics where medical acuity may not reflect the true level of need?
- How does Colorado Access capture members who fall into multiple categories (e.g., physical and behavioral health needs, housing instability, disability)?
- Will the population health assessment look at coverage impacts and what setbacks we might expect due to federal and state-level changes?
- How can the assessment ensure it is not just a "check-the-box" process but captures chronic conditions and lived experiences fully?

Policy & Emerging Updates

Carrie Jones, Health Policy Analyst, Advocacy, & Research

Reviewed federal OBBA law (July 2025) and its implications:

- Largest Medicaid funding cuts in U.S. history (~\$930B nationally).
- Colorado faces significant budget challenges and may need to adjust Medicaid services.

Key provisions:

- Community engagement requirements for expansion adults beginning January 2027.
- Semiannual redeterminations for expansion adults beginning January 2027.
- Retroactive coverage limits reduced (children: 60 days; adults: 30 days).
- Cost-sharing requirements for some adults beginning October 2028.

While children's eligibility largely remains intact, indirect impacts are expected, including provider strain and state-level funding challenges.

Colorado acted to protect access to Planned Parenthood despite federal restrictions.

Provider tax limitations may reduce state Medicaid financing, potentially affecting programs such as Medicaid buy-in.

Questions/Discussion

- How will the new Medicaid law affect children, youth, and families?
- Will parents of children be subject to the new community engagement (work/volunteer) requirements?
- How will semiannual redeterminations impact families when parents and children are on different renewal cycles?
- How will limiting retroactive coverage affect families with complex needs or those experiencing sudden health crises?
- How will cost-sharing requirements impact families and their children's access to care?
- What will happen with Planned Parenthood funding and access for Medicaid members?
- How will Colorado manage the loss of provider tax revenue, especially given it helps fund programs like Medicaid buy-in for children and adults with disabilities?

Other Suggestions:

- Preparing families for eligibility changes and churn.
- Addressing shortages of pediatric and behavioral health providers.
- Improving communication with members, especially those navigating complex needs.
- Ensuring data reflects lived experiences and community realities.
- Healthy food to children with disabilities
- Member outreach
- Language Access, and how non-English speaking communities will be impacted through the federal changes and what any community members are doing to combat changes
- How to best increase awareness of resources for members and amongst providers so we can ensure members get the wraparound care they need
- Clarity on changes that we can be expecting. Lots of misinformation. More accessibility as far as information access.
- Strategies to reach families in rural or underserved communities where access to providers is limited.
- How can COA support nonprofits' community engagement? The Continuous Coverage grant was very impactful. Our families expect one-on-one engagement. They don't engage digitally.
